If you've been paying attention you may have noticed we've changed our logo. But that doesn't mean we've changed our mission! The Y remains committed to strengthening the foundations of our community through our emphasis on youth development, healthy living, and social responsibility.

We'd like to highlight some new programs that demonstrate this ongoing commitment:

- Our 7th Grade Initiative provides every 7th grader with a free Y membership in an effort to help these youth make good life
 decisions and healthy choices at a critical time in their lives. In 2012, nearly 300 students took part in this successful program.
- In our after school programs, the **Healthy U** curriculum has been changing children's health behaviors and those of their families for three years. It is now being integrated into the elementary school day in Summit.
- LIVESTRONG® at the YMCA, our free 12-week cancer recovery and wellness program, helps adults reclaim their total health through small group therapy and exercise. This past year, 50 men and women benefited from this program.
- Our Y was instrumental in starting Summit's new ACHIEVE Community Garden on Beauvoir Avenue. The goal of this collaborative
 effort is to promote healthier eating and outdoor activity while encouraging participants from all backgrounds to work together.

With your help, in 2012 we provided over \$679K in support programs and services including those mentioned above, and distributed over \$541K in direct financial assistance to qualifying individuals and families who might otherwise not have been able to participate and benefit from our Y's offerings.

So, thank you to all of you who have given so generously to our Y! **We are grateful for your passion, talent, and commitment.** It is because of you that we can continue to support the increasing and evolving needs of our community.

YOUTH DEVELOPMENT

AT THE Y, KIDS AND YOUTH REACH THEIR PERSONAL BEST IN AN ENVIRONMENT THAT VALUES POSITIVE COMPETITION, TEAM WORK AND FAIR PLAY.

"Near the water, every parent wants to feel assured that their child is safe and knows how to swim. It is of special concern for me since my 12-year-old is a special needs child. We've tried lessons at two other pools, but he is most calm when he is at the Y and so we come here for his private weekly lesson. Quinn loves his swim instructor who praises his attitude and challenges him to take responsibility and commit to making more progress every time he comes. He intuitively feels his instructor cares. I saw something recently that said "you can save a life by teaching a kid to swim". That's why I'm here."

The Y is here to encourage every child or youth, regardless of skill or ability. In 2012, more than 1,975 kids gained the skills and confidence to be safe and have fun in the water at Y swim lessons and on the swim team. Another 1,800 kids took to the sports fields, basketball courts, wellness centers and camp grounds to experience sports and the outdoors for fun and to learn the benefits of being healthy and active.

"In all my years of coaching, this was my most challenging experience. Kids treated each other more like competitors than teammates, each wanting to be the star. I tried to show there is no "I" in team by modeling Y values. It was only in the last few games of the season when I saw the message of caring and respect for each other finally sink in. We came together as a team in the quarterfinals with a big double overtime win and won our final game (a nail-biter) playing against kids who were physically much larger. To watch my team encouraging, high-fiving, hugging and celebrating each other's success was more meaningful to me than actually winning the trophy. That's what the YMCA and youth sports can do!"

Sometimes kids need a little extra guidance and support to make sound decisions that impact them socially, academically, and physically. Last year, parents and guardians entrusted more than 800 children to the care of our Y -- from preschool and childcare programs to summer camp and programs such as the 7th Grade Initiative and YMCA Achievers.







"Over the past year, the Y Achievers program has helped me prepare for college. The program supported us with SAT prep, time management skills and reviewing potential colleges. 





