Code of Conduct

The YMCA is committed to providing a safe and welcoming environment for all members and guests. To promote safety and comfort for all, individuals are asked to act appropriately at all times when in our facility or participating in our programs. We expect persons using the YMCA to act maturely, behave responsibly, and respect the rights and dignity of others.

Participants in the 8th Grade Membership Initiative are expected to follow the same guidelines as other YMCA members with a few additional conditions. Failure to follow these policies and guidelines could result in dismissal from the 8th Grade Membership program:

- 8th Grade Members will treat staff and peers with YMCA values of caring, honesty, respect, and responsibility at all times. They can expect to be treated this way in return.
- All participants will wear appropriate workout attire, namely sneakers and no jeans.
- 8th Grade Members will stay in the designated cardiovascular workout area unless participating in a class or special event.
- Profanity or inappropriate language, as well as physical or verbal abuse directed at anyone will not be tolerated.
- The use of cell phones is permitted only in designated areas, generally the main lobby.
- Loitering in non-designated areas is not allowed.
- Drugs, alcohol and smoking are not permitted in the YMCA or on YMCA grounds.
- Locker rooms are available for use by the 8th Grade Members and are expected to be used in an appropriate, safe manner.
- The YMCA is not responsible for lost or stolen property; it is the member's responsibility to bring a lock to protect valuables. It is recommended that valuables remain home.

Waiver and Release of Liability

In consideration of gaining membership or being allowed to participate in the activities and programs of the YMCA and to use its facilities, equipment, and machinery in addition to the payment of any fee or charge, I do hereby waive, release and forever discharge the YMCA and its officers, agents, employees, representatives, executors, and all others from any and all responsibilities or liability for injuries or damages resulting from my participation in any activities or my use of equipment or machinery in the above mentioned facilities or arising out of my participation in any activities at said facilities.
