

MEMBER'S CODE OF CONDUCT

The YMCA is committed to providing a safe and welcoming environment for all members and guests. To promote safety and comfort for all, individuals are asked to act appropriately at all times when in our facility or participating in our programs. We expect persons using the YMCA to act maturely, behave responsibly, and respect the rights and dignity of others. Our Members Code of Conduct outlines prohibited action; the actions listed below are not an all-inclusive list of behaviors considered inappropriate in our facilities or programs.

- Harassment or intimidation by words, gestures, body language, or any time of menacing behavior.
- Physical contact with another person in an angry, aggressive, or threatening way.
- · Verbally abusive behavior, including angry or vulgar language, swearing, name-calling or shouting.
- Sexually explicit conversation or behavior; any sexual contact with another person.
- Inappropriate, immodest, or sexually revealing attire.
- Theft or behavior that results in the destruction or loss of property.
- The use or possession of alcohol or illegal substances/chemicals on YMCA property or at YMCA-sponsored programs.
- Loitering within or on the grounds of the YMCA.
- Disregard of facility guidelines, including cell phone use in undesignated areas.
- Smoking on YMCA property. The YMCA and its property is a smoke-free environment.
- Children under the age of 12 must be supervised by a responsible adult at all times, and are prohibited from entering the fitness center area.
- Carrying or concealing a weapon or any device or object that may be used as a weapon.
- No one having been on any sexual offender list at any time may be a member of the Summit Area YMCA, participate in the programs, be on the property or enter the facility.
- Any other conduct of an inappropriate, threatening or offensive nature.

WAIVER AND RELEASE OF LIABILITY

In consideration of gaining membership or being allowed to participate in the activities and programs of the YMCA and to use its facilities, equipment, and machinery, in addition of the payment of any fee or charge, I do hereby waive, release and forever discharge the YMCA and its officers, agents, employees, representatives, executors, and all others from any and all responsibilities or liability for injuries or damages resulting from my participation in any activities or my use of equipment or machinery in the above mentioned facilities or arising out of my participation in any activities at said facilities. I do hereby release all of those mentioned and any others acting upon their behalf from any responsibility or liability for any injury or damage to myself, including those caused by negligent act or omission of any of those mentioned or others, acting on their behalf or in any way arising out of or connected with my participation in any activities of the YMCA or the use of any equipment at the YMCA. I agree to the Code of Conduct and all policies set by the YMCA.
